

## Golf Suspension Policy for Whittlebury Park Golf Membership

#### Overview;

The Whittlebury Park golf suspension policy came into effect at the start of the new golf season on 1<sup>st</sup> April 2019.

## Update of policy;

The Whittlebury Park golf suspension policy was revised and updated for the start of the 2022/2023 season and takes effect from 1<sup>st</sup> April 2022.

# Purpose;

- To offer a golf suspension policy that is fair to all golf members and that no members are treated differently to anyone else.
- To offer a flexible suspension policy as an added benefit to members.
- To show a degree of due diligence to injuries/illness.

#### **Outline of Terms and Conditions;**

- Members who pay their annual membership fee in a pre-paid format can suspend their membership for a minimum of 1 month and a maximum of 2 months, free of charge, within a 12-month period.
- No suspension is allowed on direct debit memberships.
- The suspension policy is only applicable to memberships with a 12-month duration.
- All suspension requests must be emailed to <a href="mailto:membership@whittlebury.com">membership@whittlebury.com</a> prior to the dates requested and the membership team will email back within 72 hours with the date the members BRS account will be switched back on.
- Members must have enough time remaining on their membership to cover the full suspension, for example, we would be unable to suspend a membership for two months if there is less than 2 months remaining on the membership. We would also be unable to suspend the membership for 1 month if there was less than 1 month remaining on the membership.
- No verbal suspension request will be processed (To ensure all emails can be up help in audit and email trail should queries/discrepancies occur).
- We will not backdate suspension requests retrospectively.
- If a member suspends their membership, they will forgo any golf competitions and bookings during those months.
- All suspension dates and revised expiry dates will be held on the member's account.
- Should a member need to suspend longer than their 2 months free of charge allowance, then half their monthly membership fee will be payable from the 3<sup>rd</sup> suspension month onwards.



### Golf Suspension Policy for Whittlebury Park Golf Membership continued

## Example;

If a 7-day member needs to suspend for 4 months, months 3 and 4 will be charged and half their monthly membership fee. This is calculated at their annual fee divided by 12 and then the equivalent monthly fee divided by 2.

#### Price example;

If a 7-day member joins at a price of £1465, this would equate to £122.08 per month. £122.08 is then divided by two (£61.04). £61.04 would then be chargeable to suspended for every month over the free of charge two-month allocation per year.

- Any additional suspension payment will be payable in advance.
- Should a member suspend their membership the membership expiry date will always remain 31<sup>st</sup> March, however, the total months suspended will be reflected as a reduction on their renewal invoice.
- If a member wishes to play while on suspension, they must pay the current green fee rates advertised.
- If a member suspends a total of 6 months over 3 years, they will be considered a new member and the new member rates advertised on the Whittlebury Park website will become payable at point of renewal.
- No levy or EGU fee will be refunded.
- It can take up to 10 days for your Master scoreboard account to be reactivated from the date the suspension ends, as a result members may experience a delay of being able to book competitions.

**Summer knockout** competition entry is only available to members who have re-joined by March 31<sup>st</sup>. Players must be members of Whittlebury Park throughout the competition regardless of renewal date including member suspend.

**Winter League** - Players must be members of Whittlebury Park throughout both the league and knockout stages (the final often playing in the next subscription year) and players MUST be members of Whittlebury Park throughout the competition regardless of renewal date including member suspend.
